1. Revisions to the forecast for the year ending March 31, 2021 (April 1, 2020-March 31, 2021)

2. Reason for Revisions

Regarding the forecast of consolidated business results for the fiscal year ending March 31, 2021, sales of consumer products grew in response to heightened demand for meals prepared at home, and efforts were made to address priorities such as cost reductions. For these reasons, we expect sales and operating income, ordinary income and net income to be higher than previously forecast. Accordingly, Itoham Yonekyu Holdings has decided to revise its forecast of business results.
