## 1. Reason for Change

To realize our group philosophy and vision, our group has set "meat together" as the state we aim to be in fiscal 2035 and is promoting our "Long-term Management Strategy 2035" for fiscal 2035 and our "Medium-term Management Plan 2026" for the three years.

In addition, subject to approval at the 9th Ordinary General Meeting of Shareholders, which will be held in late June 2025, we will transition from a company with an audit and supervisory board to a company with an audit and supervisory committee, further strengthening the supervisory function of the board of directors and increasing the transparency and objectivity of management.
